# Operators, Lift Directors, Inspectors all need to be Qualified, Experts Say

The first NCCCO Industry Forum on Personnel Qualifications was an "unqualified" success according to those who attended the event in October.

The Industry Forum on Personnel
Qualifications, hosted by the National
Commission for the Certification of Crane
Operators (NCCCO), was the first of its kind
in the industry to focus entirely on the
qualification of personnel working in construction. Held in Washington, DC, it featured



presentations by senior staff from Federal OSHA and the U.S. Army Corps of Engineers as well as industry experts in their field. Read More

OSHA continues to work on a Proposed Rulemaking on the crane operator qualificationsissue, and there will be a "positive resolution" in 2016. So said Jim Maddux (pictured left), Director of OSHA's Directorate of Construction, speaking at The Industry Forum on Personnel Qualifications, hosted by the National Commission for the Certification of Crane Operators (NCCCO) in October.

Asked whether OSHA's proposed language would be based on the draft submitted to the Advisory Committee on Construction Safety and Health (ACCSH) committee earlier this year, Maddux stated that the ample feedback OSHA had received at--and following--the ACCSH meeting would ensure "without a doubt" that "what we propose will be different." New York City Approves CCO Rigger, Signalperson Certifications

## **CCO Certification Meets Building Code Requirements**

The New York City Department of Buildings has announced it has approved CCO Riggerand Signalperson certifications for use in the City. Specifically, the Department has stated that members of a rigging crew who possess valid CCO Rigger Level I and Signalperson certifications issued by the National Commission for the Certification of Crane Operators (NCCCO) fulfill the requirements of Section 3316.9.2 of the New York City Building Code. #### **Washington State Extends Contract with NCCCO**



The Department of Labor and Industries (L&I) of the State of Washington has extended its contract with NCCCO for the development and maintenance of written exams for the state's crane certifier program. NCCCO was first contracted by the state's L&I in 2008, since when more than 330 crane certifier exams have been taken. Under the agreement, which extends the contract through 2017, NCCCO works with the state's subject matter experts to review and analyze test performance

data on an ongoing basis, and provides consultation as needed on certification and psychometric issues.

Numerous questions for the written exam have been pilot-tested by the task force members, and development of the practical exam is well underway with the main tasks identified. The task force is made up of industry experts from pile driver manufacturers, users, trainers, and distributors, as well as program development and psychometric experts from NCCCO. Read More

#### Consolidated Crane Rules Due Soon from Cal-OSHA



NCCCO continues to work with Cal-OSHA and other industry members of the Crane Safety Orders Consolidation Advisory Committee on the consolidation of the state's Construction Safety Orders, "Cranes and Derricks In Construction" (Article 15), into the General Industry Safety Orders, "Cranes and other hoisting Equipment" (Article 13). In October, the Committee wrapped up its work, and the Consolidated Safety Orders should be ready for public comment during the second guarter of 2016. The Advisory Committee

also added language to the proposed Safety Orders to be consistent with the proposed language in Federal OSHA's 1926.1400 Subpart CC.

#### **International Crane Experts Meet in Australia**

The annual meeting of the International Organization for Standardization (ISO) committee that oversees development and revision of the international crane standard TC 96 took place in Sydney, Australia in September.

Hosted by the national standards setting body, Standards Australia, and sponsored by The Crane Industry Council of Australia (CICA), the meeting attracted delegates from many parts of the world to review progress on standards covering all types of mobile, tower and overhead cranes, as well as wire ro

#### This Month in CCO History . . . . 1989

The effects of a jib of a hammerhead tower crane being jumped in the center of San Francisco's financial district at morning rush hour crashing to the ground and killing five, were still being felt weeks after the November 28, accident. Although it will be 15 years before California requires crane operators to be certified, the incident provides major impetus to an existing industry initiative that, in 1995, leads to the establishment of the National Commission for the Certification of Crane Operators (NCCCO) and the country's first professionally developed national certification program.

#### Did You Know?

As a courtesy, NCCCO sends out reminders to those whose certification expiration date is approaching. Notices go out to the last address of record when a certificant enters the "recertification period" 12 months before expiration, and another reminder if they haven't recertified 6 months prior to the expiration date. This is one of the reasons it is so important to complete a **change of address** form when certificants move. Certificants don't need to have this packet to recertify. From the Seat: Blair Carlton of W.O. Grubb Talks Certification

Originally a mechanic, at 6'6" tall, Blair Carlton realized that he was better suited to be in the cab operating cranes than he was working in confined spaces.

An apprentice friend with IUOE Local 147 invited Blair to help him and his friend's father--a crane operator--on a job where they had to recover a flipped excavator with a crane. Blair was hooked: after that he knew he wanted to operate cranes, and joined the crane operator apprenticeship program at Local 147. Today he's W.O. Grubb's field operations coordinator, aka "yard supervisor", at the company's headquarters location in Richmond, Virginia, where the fleet consists of mobile, all-terrain, and rough-terrain cranes.
